# REGULAR BOARD MEETING February 8, 2016

The Bunker Hill Community Unit District #8 School Board of Education met in Regular Session at 7:00 p.m. on Monday, February 8, 2016, in the Library of the Wolf Ridge Elementary and Junior High School. President Dave Monetti called the meeting to order at 7:00 p.m.

#### **MINUTES**

## **BOARD SALUTE**

Dr. Buehler reported that Mrs. Cann was very happy that Keith Steward had been awarded a science grant from the Illinois Department of Natural Resources to create a butterfly area at Wolf Ridge. He then noted that Cheryl Best had been awarded a portrait of George Washington and an American flag that had been flown over George Washington's home which were on display in the Wolf Ridge entry by the Mount Vernon Ladies Association. Mr. Smith then commended his high school cheerleading squad for competing at State for the third consecutive year. Mrs. Miller then noted that she had been receiving positive feedback on the banners that had been installed in the gym at Wolf Ridge.

#### FINANCIAL REPORT

Dr. Buehler stated that approximately fifty-five and one half percent of the budge had been utilized to date with seventy percent of funds having been received. He noted that he was currently working on obtaining a new phone and internet system from Madison Communications utilizing e-rate funds. If obtained, this new system would allow for increased internet speed and wider bandwidths. #### COMMENTS FROM VISITORS

Brian Young was present to display the Phantom three advanced drone that he received from the EFE director. The drone has an HD camera and can fly 1.2 miles from the remote. It runs on smart batteries that detect when the drone is low on power and returns to base. The remote must be connected to an I-phone or pad to record information and utilize GPS capabilities. He noted that the device was FFA registered and would never fly above 400 feet to comply with FFA rules. He noted that area agriculture teachers are working together to develop a curriculum for drones. Some ideas they have had include checking crop populations, filming commercials, and coordinating with the business classes. Other technological advances at the high school were then discussed.
